WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT

I, _____, am the parent or guardian of a child (or children) who will be participating in the 2009-2010 **Highland High School Robotics Team FIRST** Robotics Competition (“Program”) at Highland High School”). This Program is sponsored by Highland High School”). I am fully aware that my child’s (or children’s) participation in this Program is totally voluntary.

In consideration of the **Highland High School Robotics Team** agreement to permit my child to participate in the aforementioned Program, the receipt and sufficiency in which consideration is hereby acknowledged, I agree as follows:

1) I, individually, and on behalf of my minor child (or children) and our respective heirs, successors, assigns and personal representatives, hereby release, acquit and forever discharge Highland High School Robotics Team, Highland High School and their employees, mentors, students, agents, servants, officers, trustees and representatives (in their official and individual capacities) from any and all liability whatsoever for any and all damages, losses or injuries, including death, to persons or property or both, including but not limited to any claims, demands, actions, causes of action, damages, costs, expenses and attorneys fees, which arise out of, during or in connection with my child’s (or children’s) participation in the aforementioned Programs, including but not limited to any damages, losses, or injuries to persons or property or both, which may be sustained or suffered by my child or any person in connection with my child’s (or children’s) association with, or participation in, activities at, sponsored by, or arising out of her travel to or from the University.

2) I, individually, and on behalf of my minor child (or children) and our respective heirs, successors, assigns and personal representatives, hereby agree to indemnify, defend and hold harmless Highland High School Robotics Team, Highland High School and their employees, students, agents, servants, officers, trustees and representatives (in their official and individual capacities) from any and all liability, loss or damage they or any of them incur or sustain as a result of any claims, demands, actions, causes of action judgments, costs or expenses, including attorneys fees, which result from arise out of relate to my child’s (or children’s) participation in the aforementioned Program or arising out of her travel to or from the meetings, regional and national championship events.

3) I agree that this Waiver, Release and Indemnification Agreement is intended to be as broad and inclusive as permitted by the laws of the state of Arizona and or Maricopa County, and if any portion hereof is held invalid, it is agreed that the balance hereof shall, notwithstanding, continue in full legal force and effect.

4) I hereby acknowledge and accept that there are certain risks, including bodily injury and death, that could result from my child’s (or children’s) participation in the aforementioned Program at Highland High School or an offsite for build or meeting purposes. I further acknowledge and accept that some of the workshops may cause my child to come into contact with live plants or animals, chemicals, biologics, electrical and computer equipment, or other laboratory related equipment. I have knowingly and voluntarily decided to assume the risks of these inherent dangers in consideration of the High School’s permission to allow my minor child (or children) to participate in the aforementioned Program.

5) I hereby consent to any publicity, including the use of my child’s name and likeness in connection with my child’s participation in this Program.

6) In signing this Waiver, Release and Indemnification Agreement, I hereby acknowledge and represent that I have read this entire document, that I understand its terms and provision, that I understand it affects my legal rights and those of my child (or children), that it is a binding Agreement, and that I have signed it knowingly and voluntarily.
